

Louis Riel Capital Investments Inc. (LRCI Inc.) Subsidiary of Louis Riel Capital Corporation (LRCC) Red River Metis Personal Loan Program

The purpose of this interest bearing loan program is to provide financing to Red River Metis Citizens. Louis Riel Capital Investments Inc. administers and manages the personal loan.

Description of Loan Program

Interest bearing loan up to **\$40,000.00 plus a loan set up fee.** It is available to Red River Metis Citizens who meet the general eligibility requirements.

General Eligibility

Loans will be available to Red River Metis Citizens:

- Who are employed <u>full-time</u> and have successfully completed any applicable employment probationary period;
- Who repay the loans through Pre-Authorized Debit (PAD) program directly from the client bank account.
- Who qualify with a satisfactory credit score, can provide explanations for judgements and/or collections, and have no internal debt owing to their employer.
- Whose ability to repay the loan is reflected adequately based on an analysis of current income vs debt & personal expenses.
- Who can provide collateral to secure the loan where necessary.

Terms and Conditions

| Interest: | Interest rate will be risk scored on an individual application basis and may be affected by factors such as loan amount, credit history, security, the availability of guarantors, etc. Approved applications will have a fixed interest rate. |

| Service Charges: | A one-time \$75.00 loan setup/processing fee will be charged with each advance plus any any collection fees incurred by LRCI Inc. Returned/NSF cheques will be charged \$40.00. |
| Repayment: | By Pre-authorized debit (PAD) payments from clients bank account with equal payments to be deducted each pay period to repay the loan in full by the end of the contract period. The client may elect to repay the loan at an earlier date with no penalty. |
| Deferment: | Not available |
| Guarantee: | Third party guarantee may be required |
| Collateral: | Collateral may be required in some circumstances |
