#### 1. Basis of presentation

The combined financial statements were prepared for management purposes only and include the accounts of Louis Riel Capital Corporation and its subsidiaries. Intercompany transactions and balance have not been eliminated.

The basis of accounting applied in the preparation of the financial information of Louis Riel Capital Corporation as at March 31, 2024 is on the historical basis, reflecting cash transactions with the addition of:

- receivable less an allowance for doubtful accounts
- property and equipment amortized in accordance with amounts allowable for income tax purposes
- accounts payable and accrued liabilities
- current income taxes payable as at the reporting date
- rental revenue recorded in accordance with the lease terms
- prepaid expenses
- deferred revenue based on the eligibility criteria of the funding agreements
